- **8/31 (12pm)** – Last day to fax file & access DomainWeb
- **9/1-9/4** – No case access (cutover weekend)
- **9/5** – eCourt and e-filing launch for Family Law, Probate, Mental Health and Adoptions cases
- **9/5-10/22** – Permissive e-filing
- **10/23** and moving forward – Mandatory e-filing
